#### 2. General


The TLP3350 is a photorelay in a 4-pin USOP that consists of a photo MOSFET optically coupled with an infrared LED. The TLP3350 features low output capacitance,  $C_{OFF}$ , and thus fast on/off switching of a high-frequency signal, making it ideal for switching applications in high-speed testers.

#### 3. Features

- (1) Normally opened (1-Form-A)
- (2) OFF-state output terminal voltage: 20 V (min)
- (3) Trigger LED current: 3 mA (max)
- (4) ON-state current: 200 mA (max)
- (5) ON-state resistance:  $3 \Omega$  (typ.),  $5 \Omega$  (max)
- (6) OFF-state Capacitance: 0.8 pF (typ.), 1.1 pF (max)
- (7) Isolation voltage: 1000 Vrms (min)
- (8) Safety standard




Fig. 5.1 Internal Circuit




Fig. 11.1 Switching Time Test Circuit and Waveform




Fig. 12.1.1 I<sub>F</sub> - T<sub>a</sub>




Fig. 12.1.2 I<sub>ON</sub> - T<sub>a</sub>




Fig. 12.1.3 I<sub>F</sub> - V<sub>F</sub>






Fig. 12.1.4 I<sub>ON</sub> - V<sub>ON</sub>








Fig. 12.1.6 I<sub>FT</sub> - T<sub>a</sub>






Fig. 12.1.7 t<sub>ON</sub>, t<sub>OFF</sub> - I<sub>F</sub>




Fig. 12.1.8 t<sub>ON</sub>, t<sub>OFF</sub> - T<sub>a</sub>




Fig. 12.1.9 I<sub>OFF</sub> - T<sub>a</sub>




Fig. 12.1.10 I<sub>OFF</sub> - V<sub>OFF</sub>





Fig. 12.1.11 C<sub>OFF</sub>/C<sub>OFF</sub>(0V) - V<sub>OFF</sub>
